Canarsie Civic Associations Asked for Housing Help

Community leaders
throughout Canarsie came
together at a recent meeting
of the South Canarsie Civic
Association to address the
re-emergence of illegal real
estate steering practices in
the neighborhood.

Mary Anne Sallustro, president of the civic association, said she was aware of numerous cases of homeowners being approached by realtors and urged to sell their houses below market value, usually because of some imaginary impending calamity.

Sallustro was joined by representatives from various other Canarsie civic or-

ganizations, each feeling the effects of the improper solicitation.

"We've been collecting information about these realtors," said Dr. Murray Kiok, executive director of the Hebrew Educational Society. "We'd like to know who's doing it because it is illegal."

Sallustro explained, "This particular area is under a court order prohibiting steering."

Seaview Estates Tenants Association President Mark Fertig said, "We've received reports of unscrupulous real estate agencies instilling fear for a profit motive."

"We can control steering to some extent, but not [all] steering," explained Paerdegat Civic Association President Neil Stoller. "The only ones in a position to steer are real estate agents."

While the voice of the community groups dominated the meeting, the realtors' viewpoint was present.

City Realty agent Linda Feld firmly stated, "I, and every salesman at City Realty, do not steer or illegally solicit."

"I am a successful real estate salesperson and resident of Canarsie for 38 years," explained Feld. "Almost all of the staff at City Realty are homeowners in the Canarsie area."

"Illegal soliciting is spreading because of the vacancy rate in Canarsie," explained Stoller, a resident of Canarsie for 25 years.

"This community is still viable," he added. "Why do you think people are so eager to move in?"

"Illegal solicitation is the prostituting of this neighborhood by real estate agents," said Edward Cinnirella, representing the Farragut Redwood Civic

Association. "There's a lot of money for them to make if we let them."

"Why are all of the realtors bringing in only blacks? I'm sure the blacks want an integrated neighborhood as well," said Cinnirella. "The best thing I see happening is a truly integrated neighborhood."

When each speaker had finished the floor was opened for public discussion

"Get to know your neighbor," said South Canarsie Civic member Gerry Weiner, citing racism and fear as the real problems.

"If you're going to put your houses up for sale, put them up for the right reasons," said Weiner.

"Maybe there's something wrong with me, but I'm not fearful when I leave my house," said Seymour Weiner, also a South Canarsie member. "We have no intention of leaving Canarsie."

Canarsie was recently profiled in the New York Times Real Estate section in an article entitled, "A Place That Attracts Other New Yorkers." The article, which called Canarsie "a neighborhood with a small town feeling," was a source

Canarsie is no stranger to the problems caused by illegal steering practices.

In the summer of 1991 there were several racial incidents in Canarsie, including the firebombing of the Fillmore real estate office in apparent retaliation for its showing properties in Canarsie to blacks.

Sallustro said hers and other Canarsie organizations would be gathering information and compiling a list of violators to be made available to the community and submitted to area legislators.
